Ministerial Order

WHEREAS the Commissioner of Nunavut has authority to dissolve societies that have for two consecutive years failed to make, send or file any return, notice or document required to be made, filed or sent to the Registrar pursuant to Section 26 of the *Societies Act*, R.S.N.W.T. 1988, c.S-11, as duplicated for Nunavut by s.29 of the *Nunavut Act*, S.C. 1993, c. 28.

AND WHEREAS the Registrar of Societies, pursuant to Section 27(2) of the Act, has provided both the Commissioner and the Minister of Justice lists of the names of societies in Nunavut not in good standing because they failed to comply with the statutory requirement in Section 26 of the Act;

AND WHEREAS the Commissioner of Nunavut has authority pursuant to Section 27(3) of the Act to fix a date when a society should be dissolved, unless it complies with conditions that the Commissioner considers proper;

AND WHEREAS the Minister of Justice for Nunavut has the authority to act on behalf of the Commissioner of Nunavut pursuant to Section 23(2.2)(a) and appoint a person in writing to act on behalf of the Minister pursuant to Section 23(2.2)(b)(ii) of the *Interpretation Act*, R.S.N.W.T. 1988, c.I-8, as am.

IT IS HEREBY ORDERED:

THAT the societies appearing on Appendices "A" and "B" of this Order, shall be returned to good standing by the Registrar if they comply with all of the following conditions:

1. File with the Registrar of Societies, within 180 days of this Order or a later date, if any, granted in writing at the discretion of the Registrar of Societies, all documents and information that the Registrar of Societies may require, to the satisfaction of the Registrar of Societies;
2. Remit to the Registrar all prescribed fees for such documents at the time of filing;

AND THAT failing such satisfactory filing within 180 days hereof, or a later date granted in writing at the discretion of the Registrar of Societies, each society still in default may be dissolved, and the Registrar may in his discretion exercise the powers listed in Section 28 of the *Societies Act*.
